

RAUSSER COLLEGE OF NATURAL RESOURCES MINOR DECLARATION FORM

The following minimum criteria apply to minor programs in the Rausser College of Natural Resources:

- All minors in Rausser College are available to any current UC Berkeley student in good academic standing.
- A minimum of five courses are required of which at least three are upper division.
- All upper division courses must be taken at UC Berkeley, not all must be taken in the sponsoring department.
- All courses used in satisfaction of a minor program must be taken for a letter grade, unless the course is offered only on a Pass/Not Passed basis.
- The student must achieve at least a C (2.0) average in the courses taken in satisfaction of a minor program.
- Rausser students may use only one major course to also satisfy a minor requirement. **If your major is outside of Rausser College** and you would like to use course(s) to fulfill both a major and a minor requirement, consult with your college advisor.
- Additional requirements may vary by minor. Please review the appropriate minor snapshot and consult with the minor advisor.

Instructions: Please complete the major/minor overlap check form (on the reverse side) and fill out the courses you have completed and/or planned for your major and minor programs. Obtain the signatures from your major and minor advisors. This fully completed form should be submitted to 260 Mulford Hall by the Friday of the reading/review/recitation period of the semester before you intend to graduate. Minors are posted on the students' transcript in the 'Memoranda' section, and will not appear on your diploma.
